**POLICY ON THE ESTABLISHMENT OF THE SUGAR REGULATORY
ADMINISTRATION REVIEW AND COMPLIANCE OF STATEMENT OF ASSETS
AND LIABILITIES AND NETWORTH (SALN)**

Pursuant to the provisions of Republic Act 6713, otherwise known as "The Code of Conduct and Ethical Standards for Public Officials and Employees" and in compliance with the Civil Service Commission Memorandum Circular No. 2 series of 2013, the Sugar Regulatory Administration Review and Compliance Committee has been created.

The Review and Compliance Committee shall evaluate the SALN forms submitted by the officials and employees to determine whether the same were submitted on time, accomplished completely and in proper form.

The Chairman of the Review and Compliance Committee shall administer the oaths taken by Luzon and Mindanao Area offices. The oaths taken by the Visayas Area shall be administered by the appointed Administering Officer or a lawyer.

To facilitate the proper accomplishment of the SALN Form and to avoid delay in its submission to CSC or Regional Office of the Ombudsman, the Human Resource and Records Section was assigned to ensure that each officials and employees SALN are completely filled-out and all accomplished forms are complied prior to submission to the SRA Review and Compliance Committee. To provide ample time for the Review and Compliance Committee, the Human Resource and Records Section issued a memorandum for the submission of SALN, two (2) months before the submission required by the CSC.

All officials and employees are reminded of the importance of submitting a complete and accurate SALN on time and failure to do so shall be punishable with the following penalties in accordance with Section 46 (D) (8), Rule 10 of the Revised Rules on Administrative Cases in the Civil Service.

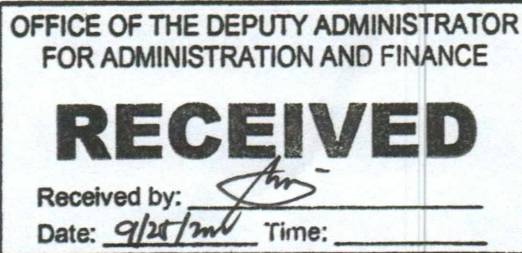


