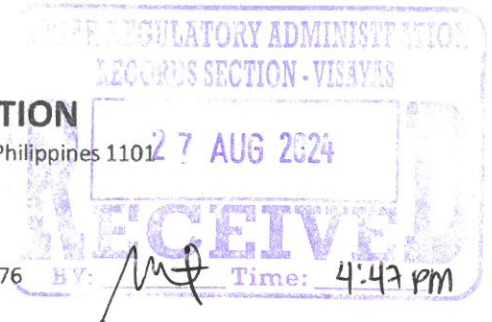

**NOTICE OF CANCELLATION OF PROCUREMENT ACTIVITIES**

Notice is hereby issued CANCELLING the above-captioned Procurement Activities (Bid Opening, including Bid Evaluation, and the succeeding Post Qualification/Evaluation Activities), with their corresponding Bid Reference Numbers, as approved by the Regional Bids and Awards Committee in its **Resolution No. 2024-28** pursuant to Section 35.6 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, which provides that

“the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the procurement activities, ***for any justifiable reason*** such as *but not limited to...*” (emphasis supplied)

Upon review of documents involved in the bidding process, it was found that the invitation sent to Observers was not received at least five (5) calendar days before the pre-bidding activity, therefore not in compliance with the requirements of the Revised IRR. In the interest of transparency and in order to satisfy the five-day notice requirement, the procurement is hereby cancelled.

In view thereof, bidders who paid the corresponding bidding documents fee for this particular requirement of SRA, have the option to apply the bidding documents fee for the re-posting of the same requirement or for future biddings of SRA wherein bidders may be interested to participate, or to claim a refund thereof. 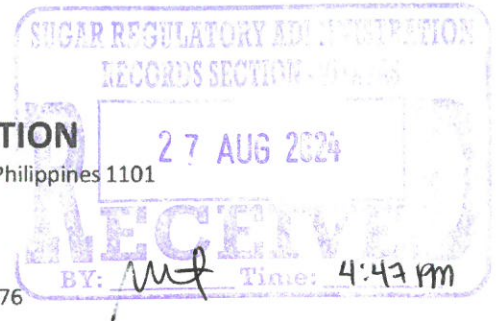

**RESOLUTION DECLARING THE CANCELLATION OF PROCUREMENT  
ACTIVITIES (BIDDING)**

**WHEREAS**, the Sugar Regulatory Administration posted Invitations to Bid for the Procurement of the following with their corresponding Bid Reference Numbers:

Project	Bid Reference Number
1. Rehabilitation of Dilapidated Fence	2024-COB-10
2. Continuation of Fencing at SRA-LGAREC Housing	2024-COB-11
3. Continuation of Rehabilitation of Crop Research Building- Phase 1	2024- SIDA-13
4. Supply and Delivery of 1 Unit Saccharimeter	2024-COB-12-REBID
5. Supply and Delivery of 40 units GPS	2024-SIDA-12-REBID

**WHEREAS**, prospective bidders submitted Letters of Intent and their representatives attended the Pre-Bid Conference last August 19, 2024;

**WHEREAS**, upon review of documents involved in the bidding process, it was found that the invitation sent to Observers was received only last August 19, 2024, therefore not in compliance with Section 13.3 of the Revised Implementing Rules and Regulations of RA No. 9184 that the notice be received at least five (5) calendar days before the pre-bidding activity;

**WHEREAS**, last August 21, 2024, the RBAC Secretariat Head and Alternate Head consulted the said concern with the Atty. Vicente Baltazar, Attorney III of GPPB and was advised to take a more conservative course of action, which is to cancel the procurement activity due to failure to comply with the five-day Notice to Observers;

**WHEREAS**, Section 35.6 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, which provides that "... the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the procurement activities, *for any justifiable reason...*". In line with the said provision, the failure to comply with the five-day notice to observers, as a mandatory requirement, may be considered one of the justifiable reasons contemplated by the rules to cause the cancellation of the procurement activity;

**WHEREAS**, Atty. Baltazar also advised that the Notice of Cancellation be posted in PHILGEPS website, in any conspicuous place, and advised/relayed to prospective bidders;
