1. JULY 28, 2018

For mills and refineries that will start their milling/refining operations between the period September and November, 2018 and

2. AUGUST 04, 2018

For mills and refineries that will start on December, 2018

After the aforesaid dates, this Office will order the printing of quedan-permit forms on the basis of each mill and refinery formats of CY 2017-2018, if no revisions were received.
