For the information and guidance of all concerned, an updated list of International Traders for Fructose (High Fructose Corn Syrup (HFCS)/Chemically Pure Fructose) with issued license for Crop Year 2022-2023 is hereby released.

In accordance with the existing rules and regulations of the Sugar Regulatory Administration (SRA), registered International Traders for Fructose must have an approved import allocation/requirement prior to fructose importation and a Clearance for Release of Fructose (High Fructose Corn Syrup (HFCS)/Chemically Pure Fructose) prior withdrawal from the Bureau of Customs (BOC) as provided in Sugar Order # 3 Series of 2016-2017.
