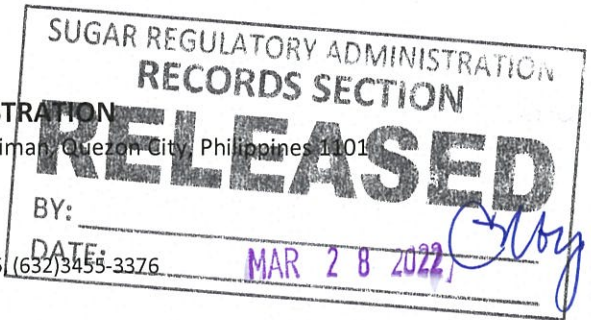

Subject : **OBSERVANCE OF 18th WOMEN WITH DISABILITIES DAY & 2022 GIRL CHILD WEEK**

The SRA joins the nation led by National Council on Disability Affairs (NCDA) and Council for the Welfare of Children (CWC) in celebrating the 18th Women with Disabilities Day on March 28, 2022 and 2022 Girl Child Week on March 28 – 31, 2022. These commemorations are within the 2022 National Women's Month Celebration (NWMC) sub-theme: "*Agenda ng Kababaihan, Tungo sa Kaunlaran*" and in compliance with Philippine Commission on Women (PCW) Memorandum Circular No. 2022-01.

This year's 18th Women with Disabilities Day Theme is "*Kababaihang may Kapansanan sa New Normal: Kapantay, Kaisa, at Kasama sa Inklusibong Kaunlaran*" in pursuant to **Proclamation No. 744, series of 2004: Declaring the last Monday of March of every year as Women with Disabilities Day** to emphasize the inclusion of women with disabilities within the society who deserve equal rights in the field of law and in all aspects of human endeavor.

The theme for 2022 Girl Child Week is "*Batang Babae: Kasama at Katuwang ng Pagbabago sa Komunidad*" in pursuant to **Proclamation No. 759, series of 1996: "Declaring every fourth week of March as the Protection and Gender-Fair Treatment of the Girl Child Week"** which underscores the need to provide every girl who is below 18 years of age with equal opportunities and adequate protection to prepare her for a role in community development.
