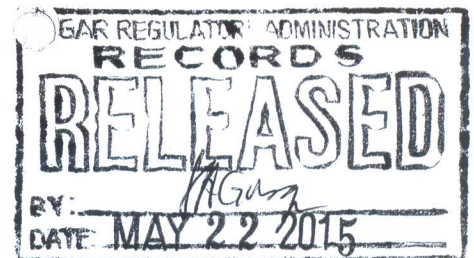

MEMORANDUM CIRCULAR NO. 3

SUBJECT : CREATION OF ISABELA MILL DISTRICT

Pursuant to the provisions of E. O. No. 18, series of 1986 and R.A. No. 9367 otherwise known as the Biofuels Act of 2006 and its Implementing Rules and Regulations (IRR) which provide that:

- *The SRA shall institute an orderly system in sugarcane production for the stable, sufficient and balanced production of sugar, for local consumption, exportation and strategic reserves (Section 2(A) of E.O. No. 18, series of 1986)*
- *The SRA shall develop and implement policies within the sugarcane industry in support of the National Biofuels Program (Section 27.1 of the IRR of R.A. 9367)*
- *The DA shall ensure increased productivity and sustainable supply of biofuels feedstocks. Towards this end, the DA in consultation with PCA, SRA and other entities concerned, shall develop and implement appropriate programs and guidelines in order to ensure a reliable supply of biofuel feedstocks (Section 11, paragraph (d)(2) of R. A. No. 9367 and Section 28 of its IRR)*



SRA, hereby declares the creation of the *Isabela Mill District* covering the sugarcane plantations of the municipalities of Isabela, Kalinga and Ifugao (Annex "A"). SRA shall provide appropriate production and extension support services to the sugarcane farmers of the Isabela Mill District which supply the feedstock requirement of Green Future Innovations, Inc. (GFII), a bioethanol plant located in San Mariano, Isabela, of URC-Cagayan Robina Sugar Milling Company (CARSUMCO) and to any production facilities using sugarcane as raw material.

Furthermore, SRA shall deploy extension personnel and other support personnel to extend the necessary services to the sugarcane farmers of Isabela Mill District. SRA is also tasked to encourage the farmers of organizing themselves into planters associations, cooperatives or the formation of Isabela Mill District Development Council Foundation for easier access of government support services.
