

REITERATION OF MEMORANDUM CIRCULAR NO. 2.,

SERIES OF 2015 RE: THREE (3)-YEAR VALIDITY PERIOD

ON THE FORMULA OF CONVERSION ISSUED BY THE INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI)

OF THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST)

All processors/exporters of sugar-based products for export under the Customs Bonded Warehouse (CBW) and non-CBW members are hereby reminded to submit their respective renewed/up-dated Formula of Conversions upon issuance by the ITDI-DOST with a validity period of three (3) years from the date of issuance per Memorandum Circular No. 2, Series of 2015, dated 08 May 2015 (copy hereto attached).

The renewed/up-dated Formula of Conversion will be one of the requirements for the renewal of the 2016 Certification of Sugar Requirements of processors/exporters of sugar-based products for export.

This Memorandum shall take effect immediately.

SUBJECT: THREE (3)-YEAR VALIDITY PERIOD ON THE FORMULA OF CONVERSION ISSUED BY THE INDUSTRIAL TECHNOLOGY DEVELOPMENT INSTITUTE (ITDI) OF THE DEPARTMENT OF

SCIENCE AND TECHNOLOGY (DOST)

In order to strengthen the SRA's sugar monitoring system and for uniformity purposes on the validity period of the Formula of Conversion is sued by the ITDI-DOST, all food processors/exporters of sugar-based products for export under the Customs Bonded Warehouse (CBW) and Non-CBW members are hereby directed to renew/update their existing ITDI with their respective ITDI-DOST Regional Offices with a validity period of Three (3) years from the date of issuance.

All concerned food processors/exporters of sugar-based products for export shall furnish the SRA of their latest/updated formula of conversion.

This Memorandum shall take effect immediately.
