ADDITIONAL REQUIREMENTS IN MONITORING THE EXPORT

SHIPMENTS OF FINISHED PRODUCTS BY THE FOOD

PROCESSORS/MANUFACTURERS OF SUGAR-BASED PRODUCTS USING "D" OR WORLD MARKET SUGAR (LOCAL AND IMPORTED)

The Sugar Regulatory Administration (SRA) hereby publishes the following additional requirements in the export shipments of finished products by the food processors/manufacturers of sugar-based products using "D" or Word Market sugar (local and imported, to wit:

- 1. The food processors/manufacturers must submit an *Outward Foreign Manifest* of the export shipment(s).
- 2. Submission of *A Notarized Deed of Undertaking to Export Finished Products Using "D" or World Market sugar (local or imported)*, copy hereto attached, to the SRA *five (5) days* before the probable date(s) of export.
- 3. CBW food processors/manufacturers should make a separate and distinct stockpile of their export products from domestic products.
- 4. All food processors/manufacturers must register with the mandatory implementation of the *E2M Automated Export Documentation System (AEDS)* in all seaport and airport by the Bureau of Customs (BOC) per *Customs Memorandum Order No. 7-2012, dated 04 May 2012* and *BOC Memorandum, dated 18 May 2012* (copies hereto attached).

Please be guided accordingly.
