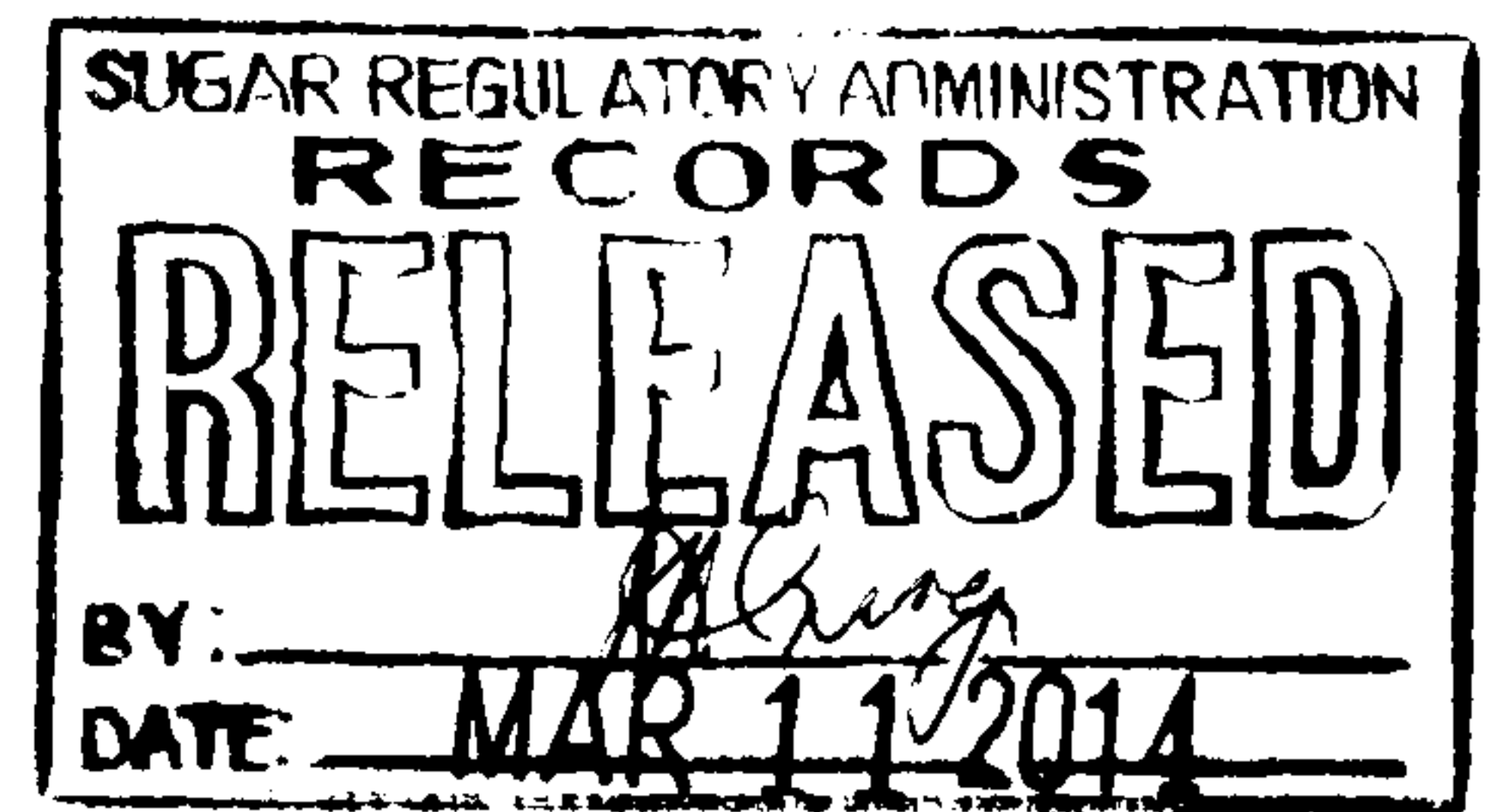

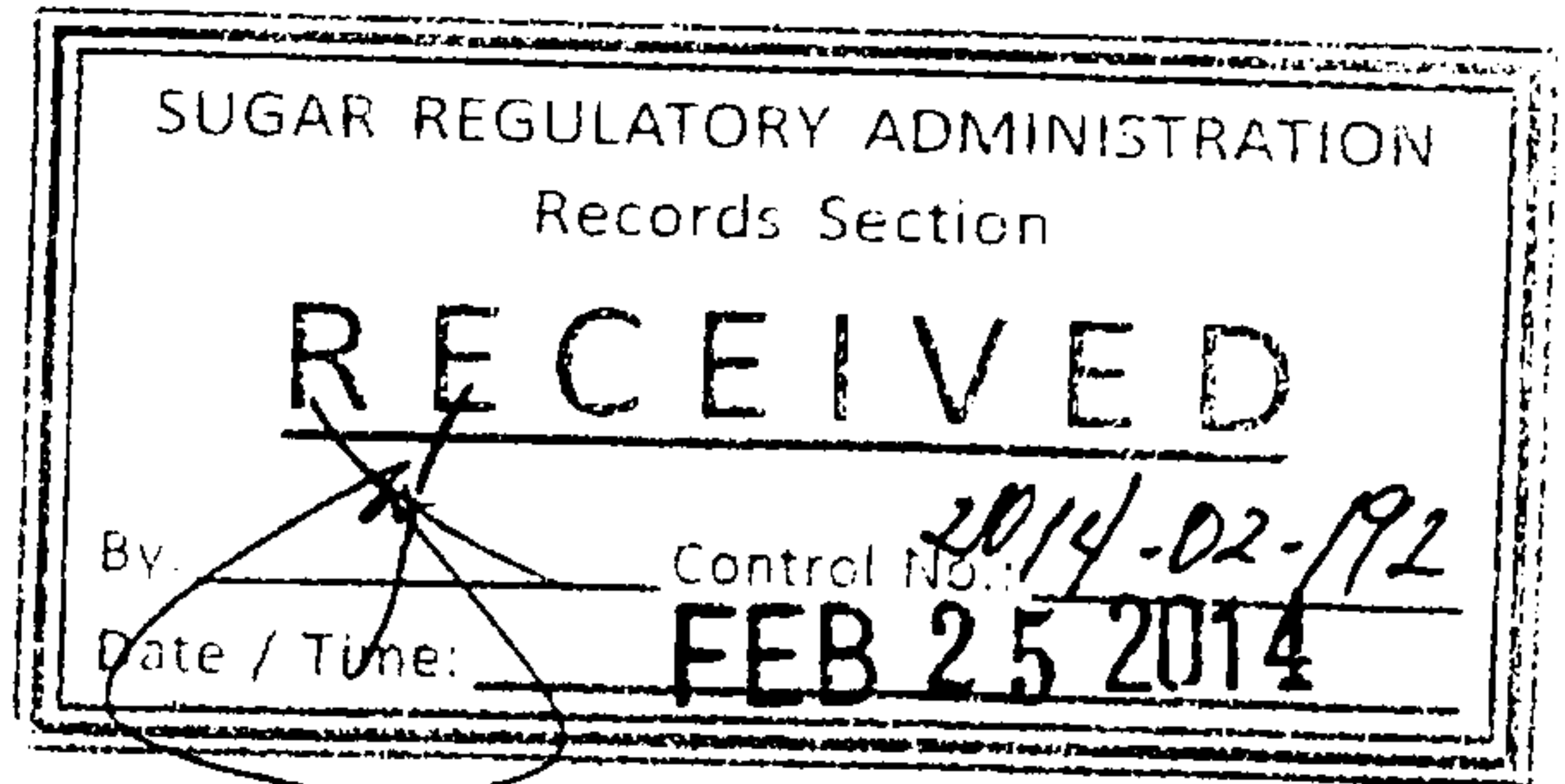

Please be vigilant. Thank you

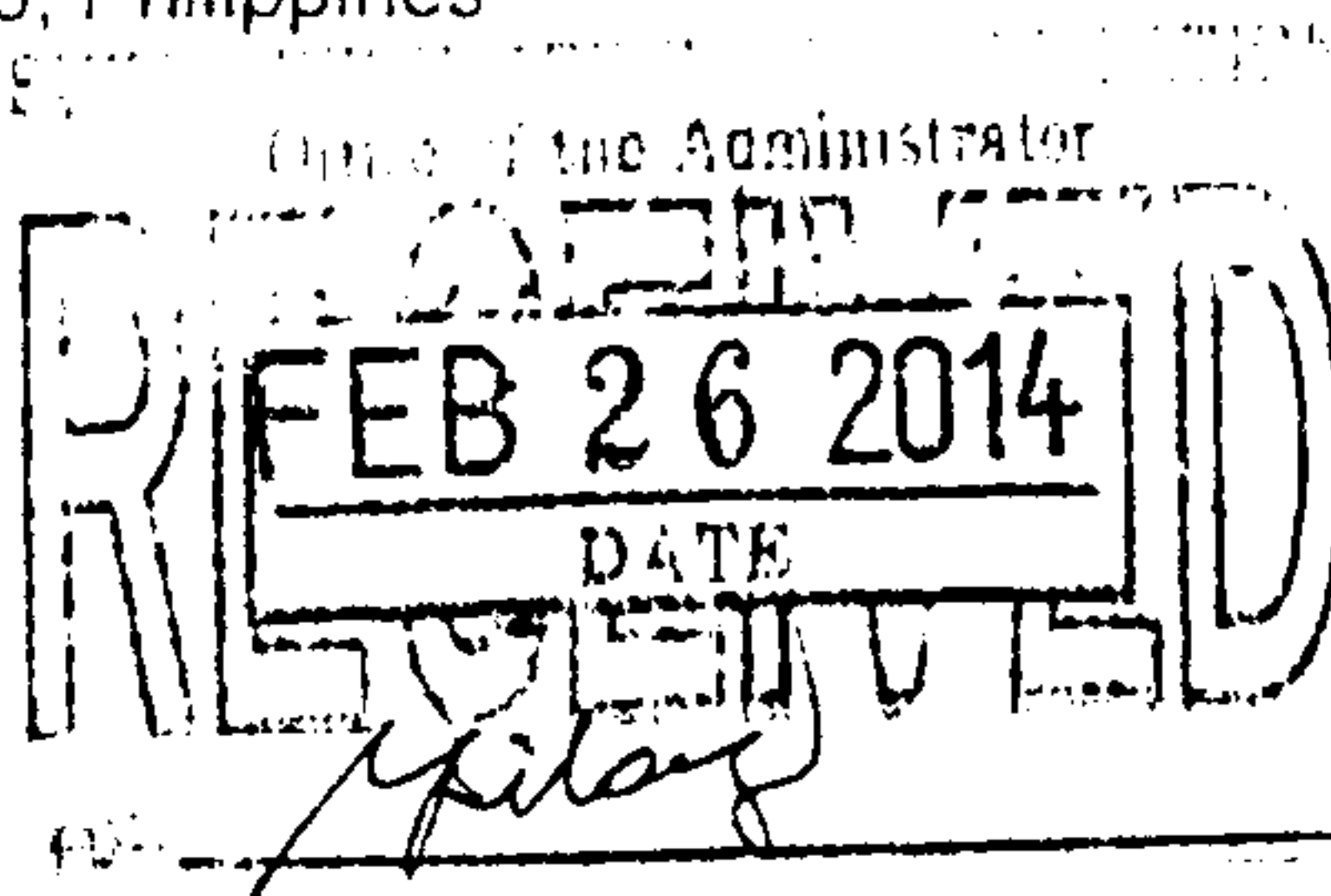

Further, it was also reported that deceit also takes place through a telephone call from a voice which is very similar to that of the Secretary's and Administrator Calayag's.

Kindly inform your staff, our stakeholders, most specifically the Chief Executives of the local government units, that such act is not and never authorized by the Department. Kindly advise our stakeholders that your office is the appropriate and authorized venue in transacting official business and should there be a hazy or doubtful situation like this, encourage them to verify or confirm with your office.
