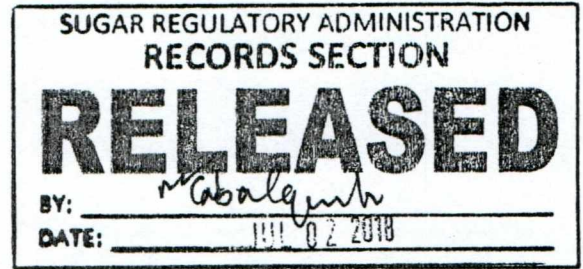

SUBJECT: RECONSTITUTING THE MEMBERSHIP OF THE SUGARCANE DISASTER RISK REDUCTION AND MANAGEMENT COMMITTEE (SUGARCANE DRRMC) & FORMATION OF SUBCOMMITTEES

WHEREAS, the Sugar Regulatory Administration (SRA) has formulated and published the Disaster Risk Reduction and Management Plan for the Sugarcane Industry (Sugarcane DRRMP) pursuant to Republic Act No. 10121 otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010";

WHEREAS, action plans were formulated under the framework of the Sugarcane DRRMP where six (6) priority areas for implementation were identified;

WHEREAS, there is a need to reconstitute the membership and strengthen the Sugarcane DRRMC in order to implement appropriate measures pertaining to disaster risk reduction and management including good governance, risk assessment and early warning systems, knowledge building and awareness raising, reducing underlying risk factors, and preparedness for effective response and early recovery;

NOW, THEREFORE, I, HERMENEGILDO R. SERAFICA, by virtue of the powers vested in me by the Sugar Board and in consideration of the foregoing premises, do hereby order the following:



All designated Alternates of Subcommittee Heads shall have the authority to act in behalf of the Heads of Subcommittees in their respective jurisdictions and in the absence of the Subcommittee Heads in order to speed up the implementation process of the DRRMP priority areas.

The Sugarcane DRRMP shall serve as guide in the identification of the programs, projects, activities and budgetary allocation attributed to the six DRRM priority areas.

This Order shall take effect upon approval by the Sugar Board.
