## INVITATION TO BID 2017-11-024 FARM TRACTORS FOR 37 BLOCK FARMS

The SUGAR REGULATORY ADMINISTRATION, through the Sugar Industry Development Act (SIDA) intends to apply the sum of Seventy Four Million Pesos (₱74,000,000.00) being the total Approved Budget for the Contract (ABC) to payment under the contract for **SRA Purchase Request No. 2017-10-500.** Bids received in excess of the ABC shall be automatically rejected at bid opening.

The SUGAR REGULATORY ADMINISTRATION now invites bids for 37 units brand new 90-Hp Farm Tractors for the 37 Block Farms of Visayas. Detailed specifications are stated under Section VII of the Bidding Documents with additional requirements, as follows:

### Tractor must have AMTEC test certification

Supplier must have owned and operated a service center for after-sales services within the region or island of delivery with at least 5 years of experience in servicing such brand being offered.

Supplier must be the sole authorized importer and distributor of the tractor.

Tractor brand or its predecessor brand must be available in the local market for at least 20 years prior to the bidding.

Supplier must provide tractor operation and maintenance training to the recipients which must be conducted by a TESDA certified trainor.

Warranty of 2 years from the acceptance of the units by the recipient.

With reflectorized SRA logo minimum of 4" diameter

In case of award, prior to the delivery the supplier must submit Bill of lading reflecting the serial numbers and country of origin/manufacture of the tractors to be delivered.

Completion of delivery is required within this year (2017).

Delivery of the Goods is required within 30 calendar days after receipt of Purchase Order. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during office hours, from 8:00 a.m. to 5:00 p.m.

A complete set of Bidding Documents may be purchased by interested Bidders starting on November 15, 2017 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **₱74,000.00.**

The Sugar Regulatory Administration will hold a **Pre-Bid Conference** on **November 22, 2017, 9:00 a.m.**, at the SRA Conference Room, Sugar Regulatory Administration, Bacolod City, which shall be open to all interested parties.

Bids must be delivered to the address below during the bid opening. All Bids must be accompanied by a bid security in any of the acceptable forms stated in **ITB** Clause 18.

**Bid opening** shall be on **December 6, 2017, 9:00 a.m.** at the Conference Room of the Sugar Regulatory Administration. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The SUGAR REGULATORY ADMINISTRATION reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
