I. Call to order: at 9:00 a.m. by RBAC Vice Chairpeson Wilfredo Monares

II. Inquiries and Clarifications

All prospective bidders present were provided with the Checklist of the Eligibility and Technical Documentary Requirements and the Technical Specifications.

- A. Clarifications from the end-users including recommendations from prospective bidders concerning some items in the Technical Specification requirements were, as follows:
 - 1. Acid Cabinet
 - Shelves "adjustable" means can be moved and make partitions
 - Volume 5 liters
 - Locking door double
 - Transparent clear or visible from the outside
 - 2. Analytical Balance
 - Capacity 120 g
 - "Zero tracking" also equivalent to "tare"
 - 3. Auto-Saccharimeter
 - Tungsten-Halogen Lamp must be compatible
 - 880-882 wavelength for samples not using lead subacetate
 - 587-589 wavelength for samples using lead subacetate
 - 4. Dispensing Machine
 - Flow rate- maximum of 2.5 li/min to 3 li/min is acceptable
 - 5. Fumehood
 - With stand; not tabletop
 - Height: 5 feet
 - 6. Microbalance
 - Set of weights Class E2
 - 7. Moisture Analyzer
 - Heating source: metal rod or halogen lamp or infrared lamp
 - Weighing balance capacity: within the range of 0-60 g
 - 8. Mupid with accessories
 - Mupid is a brand name; Change to Gel Electrophoresis Equipment
 - 9. Separate lots and budgets for the 2 units pH Meters
 - Benchtop pH Meter Php250,000.00
 - Ph/ISE Meter Php400,000.00
 - 10. pH/ISE Meter
 - Calibration point: up to 5 is acceptable
 - Manufacturer Warranty: Change to "Extended warranty on parts and services"
 - 11. Soil Mixer
 - Reduce to 4 pcs chrome-plated dispersion cups
 - 12. Separate lots and budgets for 2 units Toploading Balances
 - Toploading Balance Php50,000.00
 - Toploading Balance/Precision Php119,080.00
 - 13. Set of weights
 - Class F2
 - 14. Toploading Balance/Precision
 - Resolution-0.1 g
- B. RBAC Chairperson Atty. Ignacio S. Santillana gave emphasis on the following requirements:
 - Documents should be current.
 - For corporations, a Secretary's Certificate should be issued authorizing the signatory (of documents) and the representative.
 - For single proprietorships, a Special Power of Attorney should be issued by the owner to authorize the representative.

- Notarized documents should be compliant with notarial law; Community Tax Certificates are not acceptable as "competent evidence of identity." Only government-issued I.D.s/passport are acceptable.
- Dates in notarized documents should be in order. Date of notarization should not precede the date of authorization.
- Only the PhilGEPS Certificate of Registration is required to be submitted in lieu of the Mayor's/Business
 Permit, Tax Clearance, Audited Financial Statements/Income Tax Return and SEC Registration but if any
 of the documents are already invalid, as stated therein, the latest issued document is then required to be
 submitted.
- The SLCC requirement will be on a per lot basis
