SUGAR ORDER NO. 1-A Series of 2008-2009

SUBJECT:

ADDENDUM TO SUGAR ORDER NO. 1 SERIES

OF 2008-2009, ORDERING BLOCK QUEDANNING

OF "C" (RESERVE) SUGAR AND ESTABLISHING THE

QUEDAN FORMS TO BE USED FOR BOTH "C" & "D" SUGAR.

WHEREAS, Sugar Order No.1, Series of 2008-2009 allocated fifteen percent (15%) of the production as "C" (Reserve) sugar,

WHEREAS, various Sugar Producers' Federations have recommended that the Sugar Regulatory Administration order the block quedamning of "C" (Reserve) sugar:

WHEREAS, the Block Quedanning of CY 2008-2009 "C" (Reserve Sugar) will facilitate the availment of Quedan financing for producers through their Associations, and help prevent early disposition of "C" sugar quedans at unfairly low prices;

NOW THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered.

Section 1. ADDENDUM TO SUGAR ORDER NO. 1. SERIES OF 2008-2009. The following sections (3a/3a.1/3a.2) shall constitute an addendum to Sugar Order No. 1 ("08-'09):

Section 3a. Block Quedanning of "C" sugar. In the case of "C" (Reserve) sugar, each mill company shall issue blocked (consolidated) weekly sugar quedan-permits under the name of the concerned association/cooperative with an attached listing of the plantermembers and their corresponding production covered by said sugar quedan-permits. Planters who choose to have their "C" sugar quedans issued individually shall write the concerned mill, which shall automatically implement the issuance of the individual quedans starting the week-ending after receipt of such letter, copy furnished the SRA;

3a.1. The "B" or Domestic sugar quedan-permit forms for Crop Year 2008-2009 shall be used to cover every week-ending's production of "C" or Reserve sugar and validated by the SRA Sugar Regulation Officers assigned at the millsites by stamping the said "B" quedans as "C" or Reserve sugar.

- 3a.2. In the same manner, the "A" or U.S. Quota sugar quedanpermit forms shall be used to cover every week-ending's
 production of "D" or World Market sugar and shall be issued
 after the said "A" quedan-permits have been properly
 stamped as "D" or World Market sugar and validated by the
 SRA Sugar Regulation Officers assigned at the millsite.
- Section 2. Other provisions of Sugar Order No. 1 Series of 2008-2009 not contrary hereto shall remain in full force and effect.
- Section 3. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order are hereby revised, modified or revoked accordingly.

Section 4. Effectivity. This Sugar Order shall take starting production week-ending September 21, 2008.
