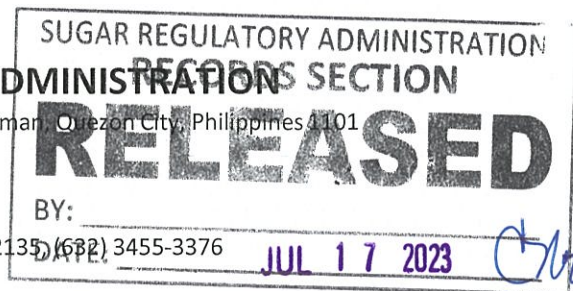

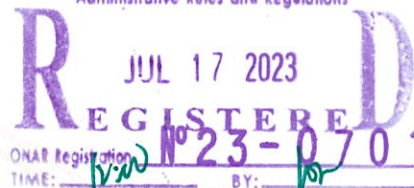

**SUBJECT : OMNIBUS GUIDELINES FOR THE REINSTATEMENT OF HOMELESS "A" AND "D" QUEDANS**

**WHEREAS**, previous Sugar Orders have declared all homeless "A" or U. S. Market sugar quedans available for reinstatement, subject to certain conditions, otherwise these shall remain homeless, non-negotiable, and non-marketable;

**WHEREAS**, previous Sugar Orders had likewise provided for guidelines for disposition of "D" or World Market sugar for Export or for consumption of sugar-based food exporters, outlining therein the conditions for declaring "D" quedans as "Homeless," as well as that for its reinstatement, including the reinstatement fee of P10.00 per LKg-bag;

**WHEREAS**, the Sugar Regulatory Administration had received various queries and requests to avail of reinstatement of homeless "A" and "D" sugar quedans;

**WHEREAS**, the reinstatement of homeless "A" and "D" sugar quedans which remain outstanding as per official records of SRA is in order;

**NOW THEREFORE**, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), the following is hereby ordered:

**Section 1. Approval of Reinstatement.** The approval of any request for reinstatement of "A" or "D" sugar quedans shall only be upon the sole authority of the Sugar Board.

**Section 2. Reinstatement Fees.** The reinstatement fee for homeless "A" and "D" sugar quedans shall be as follows:

For homeless "A" sugar quedans: P15.00 per LKg-bag upon filing of the request for reinstatement.

For homeless "D" sugar quedans: P15.00 per LKg-bag upon filing of the request for reinstatement.




**Section 3. Period of Reinstatement.** Application for reinstatement shall be until August 4, 2023;

**Section 4.** This Order shall take effect immediately.

**Section 5.** Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order are hereby revised, modified, or revoked.
