SUGAR ORDER NO. 4-A
Series of 2006-2007

SUBJECT : AMENDMENT AND ADDENDUM TO SUGAR ORDER NO. 4, SERIES OF 2006-2007 RE: CONVERSION OF "C" OR RESERVE SUGAR INTO "D" OR WORLD MARKET SUGAR AND THE REVISED SUGAR CLASSIFICATION AND PERCENTAGE ALLOCATION

WHEREAS, there is a need to encourage our CBW Food processors/exporters to source their sugar requirements from our local production instead of importing them from the World Market;

WHEREAS, there is also a need to amend Section 3 of Sugar Order No. 4, Series of 2006-2007, dated 26 October 2006 in order to distinguish the nomenclature classification of our locally produced sugar for the CBW Food Processors/Exporters and the World Market to avoid confusion;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that;

Section 1. Section 3 of Sugar Order No. 4, Series of 2006-2007 is hereby amended to read as follows:

"Section 3. The "D" sugar may be made available to the food processors of sugar-based products for export under the Customs Bonded Warehouse (CBW) chargeable to their 2007 import allocation **provided the "D" sugar when availed of by the CBW Food Processors/Exporters shall be first reclassified as "E" or CBW Food Processors/Exporters sugar by the SRA prior to its availment and eventual withdrawal for refining as "E" sugar.**"


Section 2. Priority on the CBW Processor/Exporter sugar. CBW Processors/Exporters of sugar-based products with approved SRA Certificate of Sugar Requirements (import allocation) for the years 2006 and 2007 are given the first (1st) priority to avail of the allocated "D" or the World market sugar for reclassification into "E" or CBW Processor/Exporter sugar over actual export to the World Market.

Section 3. This Order shall take effect immediately.

Section 4. A Circular Letter shall be issued as implementing guidelines of this Order.

Section 5. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this order are hereby amended, revoked or modified accordingly.
