OF **EXPORT MARKET** SUGAR OF CURRENT AND PREVIOUS CROP YEARS

WHEREAS, Section 2, (B) of Executive Order No. 18, Series of 1986 mandates the Sugar Regulatory Administration (SRA) to establish and maintain such balanced relation between sugar production and the requirements of the market, and to maintain such marketing conditions as will ensure stabilized prices at levels reasonably profitable to producers and fair to consumers;

WHEREAS, there is a need for the SRA to make an accounting of all "A" U.S. Export Market Sugar issued for CY 2019-2020 and previous crop years to determine the total available volume of all outstanding "A" sugar quedans;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration, the following is hereby ordered:

Section 1. Coverage for Verification. "A" U.S. Export Market Sugar quedan-permits issued for the current Crop Year 2019-2020 and previous crop year/s, regular, reinstated and swapped are eligible for verification under this Sugar Order.

Section 2. Deadline for Verification. The deadline for the filing of the application of verification of the "A" U.S. Export Market sugar quedan-permits shall not be later than September 7, 2020.

Section 3. Failure to verify the "A" U.S. Export Market sugar subject of this Order shall be classified as "Homeless" quedans and its covering sugar is non-status, non-negotiable or marketable and cannot be withdrawn from the Mills unless specifically authorized by the SRA.

Section 4. Application for verification shall be filed at the Regulation Department, SRA, both in Quezon City and Bacolod City.

Section 5. This Order shall take effect immediately.

Section 6. Provisions of Sugar Orders, Circular Letters, rules and regulations contrary to or inconsistent with this Sugar Order is hereby revised, modified and revoked.
