VERIFICATION OF "A" U.S. EXPORT MARKET SUGAR COVERING SUGAR PRODUCTION WEEK ENDING 04 APRIL 2021 AND **SUBSEQUENT WEEKENDINGS OF CROP YEAR 2020-2021** AND PREVIOUS CROP YEARS

SUGAR REGULATORY ADMINISTRATION RECORDS SECTION

WHEREAS, Section 2, (B) of Executive Order No. 18, Series of 1986 mandates the Sugar Regulatory Administration (SRA) to establish and maintain such balanced relation between sugar production and the requirements of the market, and to maintain such marketing conditions as will ensure stabilized prices at levels reasonably profitable to producers and fair to consumers;

WHEREAS, Sugar Order No. 1-A, Series of 2020-2021 was issued amending Sugar Order No. 1, Series of 2020-2021 re: Sugar Policy for Crop Year 2020-2021, wherein the new sugar allocation is 100% "B" or Domestic Sugar Market;

WHEREAS, there is a need for the SRA to make an accounting of all "A" U.S. Export Market Sugar covering sugar production week ending 28 March 2021 and prior week endings of CY 2020-2021 and previous crop years 2019-2020 and CY 2018-2019 to determine the total available volume of all outstanding "A" sugar quedans;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration, the following is hereby ordered:

Section 1. Coverage for Verification. "A" U.S. Export Market Sugar quedan-permits covering sugar production week ending 28 March 2021 and prior week endings of CY 2020-2021 and "A" quedans including swapped quedans of previous crop years 2019-2020 and CY 2018-2019, are eligible for verification under this Sugar Order.

Section 2. Deadline for Verification. The deadline for the filing of the application of verification of the "A" U.S. Export Market sugar quedan-permits shall not be later than June 18, 2021.

Section 3. Failure to verify the "A" U.S. Export Market sugar subject of this Order shall be classified as "Homeless" quedans and its covering sugar is non-status, non-negotiable or marketable and cannot be withdrawn from the mills unless specifically authorized by the SRA.

Section 4. Application for verification shall be filed at the Regulation Department, SRA, in Quezon City or Bacolod City.

Section 5. This Order shall take effect immediately.

Section 6. Provisions of Sugar Orders, Circular Letters, Memorandum Circulars, rules and regulations contrary to or inconsistent with this Sugar Order is hereby revised, modified and revoked.
