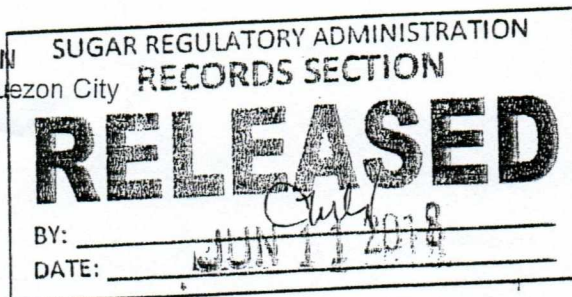

**SUBJECT: VERIFICATION OF "A" U.S. QUOTA SUGAR PRODUCED IN CROP YEAR 2017-2018 AND PRIOR YEARS**

**WHEREAS**, the Sugar Regulatory Administration, in exercise of its regulatory function and for the purpose of ensuring the Philippines compliance with its U.S. Quota allocations, issued several Sugar Orders in the past setting for the deadline for verification of "A" U. S. Quota Sugar for a particular crop year;

**WHEREAS**, the verification of "A" U. S. Quota Sugar is a long established system by which all sugar produced under the foregoing class is accounted for, purposely to determine our capability to perform our U.S. Quota obligations;

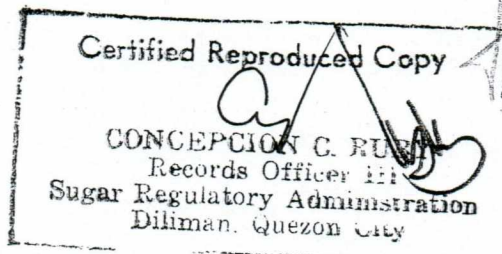
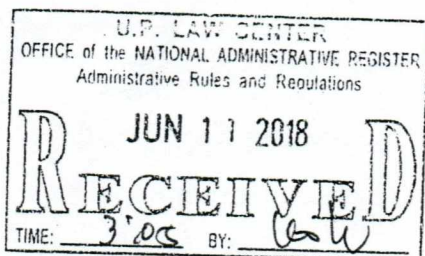
**WHEREAS**, the Sugar Regulatory Administration has determined that for the purpose of proper monitoring and accounting of all remaining and unshipped "A" U. S. Quota Sugar, there is a need for verification of all "A" U. S. Quota Sugar produced in Crop Year 2017-2018 and CY 2016-2017;

**NOW, THEREFORE**, under and by virtue of the regulatory powers vested in the Sugar Regulatory Administration, it is hereby ordered that:

**Section 1. Coverage of Verification.** "A" U. S. Quota Sugar quedan-permits issued for Crop Year 2017-2018 and Crop Year 2016-2017, regular, reinstated and swapped are eligible for verification under this Sugar Order.

**Section 2. Deadline for Verification.** The deadline for verification of "A" U.S. Quota Sugar produced as of week ending May 27, 2018 Crop Year 2017-2018 and previous Crop Year 2016-2017 shall be on June 29, 2018.

**Section 3.** Failure to verify the "A" U. S. Quota Sugar subject of this Order shall be classified as "Homeless" quedans and its covering sugar is non-status, non-negotiable or marketable and cannot be withdrawn from the mills.





Section 4. Application for verification shall be filed at the Regulation Department, SRA, Quezon City.




