**SUGAR ORDER NO. 4-A**  
Series of 2001 – 2002

**SUBJECT :** AMENDMENT TO SUGAR ORDER NO. 4, SERIES OF  
2001 – 2002 RE: MINIMUM ACCESS VOLUME (MAV)  
SUGAR IMPORTATION FOR THE YEAR 2002

**WHEREAS**, the Sugar Regulatory Administration (SRA) is mandated to promote the effective merchandising of locally produced sugar in the domestic market so that those engaged in the sugar industry will be placed on a basis of economic viability;

**WHEREAS**, the 17,347 MT sugar importation of the National Food Authority (NFA), which is part of the 56,933 MT MAV importation for the year 2002, shall be subject to the same amount of liens collected from the other MAV importers/consignees pursuant to Sugar Order No. 4, Series of 2001-2002;

**WHEREAS**, there is a need to amend certain provision of Sugar Order No. 4, Series of 2001-2002;

**NOW, THEREFORE**, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

**SECTION 1.** Section 1 of Sugar Order No. 4, Series of 2001-2002, is hereby amended to read as follows:

**"SECTION 1.** The NFA, one of the importers/consignees of the imported sugar under the MAV for the year 2002 shall apply with the SRA for clearance prior to the release of the commodity from the Bureau of Customs (BOC).

The said importer/consignee shall submit to the SRA a letter-request for clearance, attached thereto the following pertinent documents of importation namely: i) MAV Import Certificate/Official list of MAV sugar importation, ii) Commercial Invoice, and iii) Bill of Lading and shall pay the amount of liens directly to the SRA as payee, namely: i) ₱ 34.90/LKg-Bag if raw sugar importation, or ii) ₱ 37.75/LKg-Bag if refined sugar importation, as Clearance Fee."

**SECTION 2.** Provisions of Sugar Orders, Circular Letters, rules and regulations inconsistent with or contrary to this Order are hereby revoked, amended or modified accordingly.

**SECTION 3.** This Order shall take effect immediately.
