Sugar Order No. 10 Series of 2005-2006

SUBJECT

SWAPPING AND/OR PHYSICAL EXCHANGE OF RAW
"B-2" OR NFA SUGAR WITH AVAILABLE REFINED SUGAR

WHEREAS, the NFA in its letter to the SRA dated 27 April 2006 requested for approval of the "swapping" of "B-2" sugar quedans with the available refined sugar in order to provide the domestic market especially in Metro Manila with affordable refined sugar to stabilize prices;

WHEREAS, the SRA sees that there is a need to approve said request to enable the NFA to save on cost of tolling and transporting the "B-2" sugar in refined form from the different sugar refineries in the Visayas/Mindanao to Metro Manila to facilitate and expedite the distribution/disposition in the domestic retail markets;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

Section 1. The "B-2" sugar quedans liquidated by the NFA from the sugar producers of Crop Year 2005-2006 can be applied for swapping.

Section 2. The application for "swapping" shall be done by the NFA through a letter of application filed with the SRA, Quezon City attached thereto the following:

- 1. Physical "B-2" quedans and RSQ
- 2. Listings of the said quedans
- 3. Affidavit as to the ownership of the subject sugar
- 4. Memorandum of Agreement (MOA) between the NFA and the sugar traders as to the winning bidder duly notarized, manifesting the exchange of the "B-2" sugar with the available refined sugar.

- **Section 3.** The approved "swapping" shall authorize the withdrawal of the sugar through the surcharging of the "B-2" NFA sugar quedans with available refined sugar per Sugar Order No. <u>10</u>, Series 2005-2006 and the issuance of the corresponding Letter of Authority to the concerned mills.
- **Section 4.** This type of "swapping" is only applicable to the "B-2" sugar quedans of the NFA issued this CY 2005-2006 and not to other classes of sugar quedans issued by the mills.
 - **Section 5.** This Order shall take effect immediately.
 - **Section 6.** Provisions of Sugar Orders, Circular Letters, and/or other rules and regulations contrary to or inconsistent with this Sugar Order, are hereby amended, modified or revoked accordingly.
