AMENDMENT TO SUGAR ORDER NO. 8, DATED 07 MARCH 2006. SUBJECT :

SERIES OF 2005-2006 RE: FILLING UP THE ADDITIONAL U.S. QUOTA

QY 2005-2006

WHEREAS, we have to take into account the condition which slowed down the full implementation of Sugar Order No. 8, Series of 2005-2006;

WHEREAS, Binalbagan-Isabela Planters' Association (BIPA) and other planters' associations had made an appeal with the SRA on behalf of their members who could not be notified on time to extend the deadline of the verification date for their "A" quedans issued on week-ending March 5, 2006 and prior week-endings, said deadline was on March 31, 2006 per said Sugar Order No. 8;

WHEREAS, there is a need to amend certain provisions in the said Sugar Order No. 8;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

Section 1. Section 1a of Sugar Order No. 8, dated 07 March 2006, Series of 2005-2006 is hereby amended to read as follows:

"Section 1a. In order to ensure the filling up of the additional U.S. Quota at the appropriate time, hereunder is the scheduled deadline of submission of "A" quedans of CY 2005-2006 to the PCRO, SRA, Quezon City for verification which will serve as the traders'/exporters' allocation to the U.S. Quota, to wit:

> Week-ending Date of Production CY 2005-2006

March 5, 2005 and prior week-endings

March 12, 2006 - March 26, 2006

April 2, 2006 - April 30, 2006

May 7, 2006 - May 28, 2006

June 4 - End of Milling

Deadline of Submission for Verification

April 28, 2006

May 19, 2006

June 9, 2006

To be announced later"
