

SUBJECT : Amendment to Sugar Order No. 4, Series of 2017-2018

Re: Guidelines for Verification and Disposition of

"D" or World Market Sugar

WHEREAS, there have been requests from several sugar traders/exporters to extend the March 15, 2018 deadline indicated in Sugar Order No. 4 for the shipment and/or commitment for sale to CBW/food processors and ethanol producers of the "D" sugar;

WHEREAS, SRA finds validity of these requests for extension to move out "D" sugar from the warehouse of the mill and facilitate the export/load transaction of "D" to "E" and "D" to "F" sugars;

WHEREAS, there is a need to amend certain provisions of Sugar Order No. 4, Series of 2017-2018 by extending the deadline of shipment and/or commitment for sale to CBW/food processors and accredited ethanol producers from above-cited reasons;

NOW, THEREFORE, under and by virtue of the authority vested in the Sugar Regulatory Administration (SRA), it is hereby ordered that:

Section 1. Section 1.3 of Sugar Order No. 4, Series of 2017-2018 is hereby amended to read as follows:

Section 1.3. Hereunder is the new deadline of shipment and/or commitment for sale to CBW/food processors and accredited ethanol producers upon the request of the sugar traders/exporters;

Deadline of Shipment and/or Commitment for Sale to CBW/Food Processors and Ethanol Producers of "D" Sugar	
From	То
March 15, 2018	June 15, 2018

Section 1.3.1 The abovementioned new deadline is final and any further requests for extension shall not be entertained.

Section 2. The subject "D" sugar quedans which will not meet the prescribed deadline of June 15, 2018 as provided for in Section 1.3 shall be considered as homeless and non-marketable, which sugar cannot be withdrawn from the mills unless specifically authorized by the SRA.

Section 2.1 Homeless guedans referred to in Section 2 shall be disposed of in accordance with Sugar Order Nos. 12, No. 12-A-and-Circular Letter No. 35 Series of 2013-2014; Circular Letter No. 5 Series of 2008-2002 erspine or and Circular Letter No. 16 Series of 2005-2006.

Section 3. Sugar traders/exporters who will not meet the initial deadline of March 15, 2018 but shall avail of the final June 15, 2018 deadline shall pay an Extension Fee of PhP15.00/LKg-Bag.

**Section 4.** Other provisions of the aforesaid Sugar Order No. 4, Series of 2017-2018 shall remain in full force and effect.

**Section 5.** Provisions of sugar orders, circular letters, rules and regulations that are contrary to or inconsistent with this Order are hereby amended, modified or revoked accordingly.

Section 6. This Order shall take effect after Fifteen (15) days from its publication.
