With reference to the Bidding Documents for the supply and delivery of Farm Implements (SIDA), posted at the PhilGEPS and SRA websites, this Supplemental/Bid Bulletin is being issued to clarify, amend, modify the provisions in the Bidding Documents in response to the queries raised by prospective bidders, as follows:

Section III. Bid Data Sheet	
From	
ITB Clause 5.4	The Bidder must have completed, within the period specified in the Invitation to Bid and ITB Clause 12.1(a)(ii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. For this purpose, similar contracts shall refer to Agricultural Implements.
To	
ITB Clause 5.4	In view of the determination by the Procuring Entity that imposition of the provisions of Section 23.4.1.3 of the IRR of RA 9184 will likely result to [State “failure of bidding” or “monopoly that will defeat the purpose of public bidding”], the Bidder should comply with the following requirements: a) Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least [State “fifty percent (50%)” in the case of Non-expendable Supplies and Services or “twenty-five percent (25%)” in the case of Expendable Supplies] of the ABC for this Project; and b) The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above. For this purpose, similar contracts shall refer to Agricultural Machinery/ Implements.

BIDDER'S WRITTEN QUERY

AGRICOMPONENT CORPORATION	
Query 1	For the SLCC, farm tractor with implements should be considered.
RBAC's Reply	Request GRANTED. Similar contracts shall refer to Agricultural Machineries/Implements
Query 2	To allow the AMTEC Staff to be present during the actual post-evaluation testing to, likewise, conduct testing for the issuance of the AMTEC Test Reports since the AMTEC Test Reports for the Farm Implements are not yet available.
RBAC's Reply	Query to be considered if the AMTEC agrees with the request and provided that the testing is considered valid and the resulting written report is good as approved by the AMTEC.
Query 3	Delivery period should be adjusted to 90 calendar days to consider the pandemic present situation.
RBAC's Reply	Request DENIED.
ALL CERTIFIED EQUIPMENT AND TRADING CORPORATION	
Query 1	To consider and allow to use an SLCC consisting of tractor with implement
RBAC's Reply	Request GRANTED. Similar contracts shall refer to Agricultural Machineries/Implements
Query 2	To consider 90 calendar days for the delivery period.
RBAC's Reply	Request DENIED.
ABOMAR EQUIPMENT SALES CORPORATION	
Query 1	Delivery period up to 90 calendar days upon receipt of Notice to Proceed.
RBAC's Reply	Request DENIED.
Query 2	Allow to submit two (2) invoices to satisfy the 50% requirement of the ABC. Allow to use invoices of tractors provided the invoice indicates that the purchase was coupled with a farm implement/attachment.
RBAC's Reply	Request GRANTED. Completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least "fifty percent (50%)" of the ABC for this Project; and the largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above. Similar contracts shall refer to Agricultural Machineries/Implements.

The Supplemental/Bid Bulletin No. 1 shall form part of the Bidding Documents. Any provisions in the Bidding Documents inconsistent herewith is hereby amended, modified and superseded accordingly.
