**INVITATION TO BID  
FOR  
SUPPLY AND DELIVERY OF ONE (1) UNIT ATOMIC ABSORPTION  
SPECTROPHOTOMETER (AAS)**

1. The **Sugar Regulatory Administration** through the **2019 General Appropriations Act (GAA) Continuing Budget (SIDA)** intends to apply the sum of **Two Million Five Hundred Thousand Pesos and 00/100 (Php2,500,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of One (1) Unit Atomic Absorption Spectrophotometer (AAS)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Sugar Regulatory Administration (SRA)** now invites bids for **Supply and Delivery of One (1) Unit Atomic Absorption Spectrophotometer (AAS)**. Delivery of the Goods is required **ninety (90) calendar days from receipt of the Notice to Proceed (NTP)**. Bidders should have completed, within **three (3) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from **BAC Secretariat, Sugar Regulatory Administration (SRA)** and inspect the Bidding Documents at the address given below during **8:00 AM – 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **January 28, 2020 to February 18, 2020** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php5,000.00**

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **Sugar Regulatory Administration (SRA)** will hold a Pre-Bid Conference on **February 05, 2020/ 9:00 A.M.** at the **SRA Social Hall, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **February 18, 2020, 2:00 PM.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.**

Bid opening shall be on **February 18, 2020, 2:00 P.M.** at the **SRA Social Hall, Sugar, Sugar Regulatory Administration (SRA), North Avenue, Diliman, Quezon City.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. No bidder shall "Deal Secretly" or give commission to any SRA Officers/Employees pursuant to SRA Memorandum dated September 8, 2016. Violation of this restriction shall be a ground for disqualification.

The **Sugar Regulatory Administration (SRA)** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
