INVITATION TO BID

The Sugar Regulatory Administration (SRA), through its Asset Management and Disposal Committee (AMDC), hereby invites all interested parties to participate in the public auction through Sealed Public Bidding of various unserviceable properties on a per lot and "as-is-where-is" bases as indicated below:

All unserviceable properties for sale are located at the main office of the Sugar Regulatory Administration in North Avenue, Diliman, Quezon City.

Prospective bidders may conduct inspection from August 1, 2024 to August 7, 2024 from 8:00 a.m. to 3:00 p.m., except weekend and holiday/s. Bid forms will be issued during this period.

An auction bond equivalent to ten percent (10%) of the floor price in the form of cash or manager's/cashier's check from a commercial or universal bank must be submitted together with the bid and other required documents.

The properly signed bid offer or auction tender must be submitted in three (3) copies in a sealed and marked envelope address to the AMDC Chairperson. The AMDC shall not be responsible for any tampering of unsealed bids.

Deadline of submission of bids is on August 9, 2024, 9:00 a.m. at the Social Hall, Sugar Regulatory Administration, North Avenue, Quezon City. Modification/withdrawal of bids shall not be allowed after the deadline. A bidder may withdraw his/her bid after it has been submitted for valid and justifiable reason, provided that the Letter of Withdrawal is received by the AMDC prior to the deadline of submission of bids.

Opening of bids is on August 9, 2024, 9:30 a.m. at the Social Hall, Sugar Regulatory Administration, North Avenue, Diliman, Quezon City.

Bids will be opened in the presence of all the bidders or their duly designated representatives and the COA representative. Auction tenders that are not in the prescribed form and/or not accompanied by auction bonds and qualification documents at the time of opening of bids are considered defective, hence, shall be automatically disqualified.

The bid bond of non-winning bidders shall be returned outright. Bid offer/s shall be valid for sixty (60) calendar days.

One-time payment in the form of cash, cashier's check or manager's check or any other digital modes shall be made within five (5) working days from the date of receipt of the Notice of Award. The bid bond shall be forfeited in favor of the SRA if the winning bidder refuses to accept the award and in case the winning bidder fails to make the payment within the prescribed period.

The winning bidder shall be given five (5) working days from the full payment of the bid price, to pick-up and haul the properties. Expenses incidental to the pick-up/hauling of the properties shall be borne by the winning bidder.

Failure of bidding shall be declared if no bids were received or if all bidders failed to comply with the terms and conditions in the Invitation to Bid and Instruction to Bidders.

The SRA-Asset Management and Disposal Committee reserves the right to reject any or all bids and to annul the bidding process any time prior to the award of contract, without hereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the SRA's actions.

Let copies of this Invitation be posted from August 1 to 7, 2024 to at least three (3) conspicuous areas within and outside of SRA, and on the SRA website in order to invite qualified bidders.
