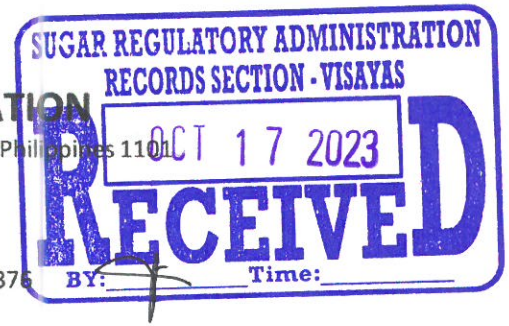

INVITATION TO BID FOR SUPPLY AND DELIVERY OF FOOD BASKET FOR SRA VISAYAS EMPLOYEES (2023-COB-22)

1. The SUGAR REGULATORY ADMINISTRATION, through the Corporate Operating Budget 2023, intends to apply the sums of **Four Million Five Hundred Thousand Pesos ((P4,500,000.00))** being the ABC for payments under the contract for **Supply and Delivery of Food Basket for SRA Visayas Employees/ 2023-COB-22**. Bid received in excess of the ABC shall be automatically rejected at bid opening.
2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the above Procurement Project. Delivery of the Goods is required **on or before December 20, 2023** upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project plus it must adhere to the description of an eligible bidder as contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from the SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested Bidders on October 17 to November 7, 2023 from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amounts indicated below. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

6. The SUGAR REGULATORY ADMINISTRATION will hold a Pre-Bid Conference on October 24, 2023; 2:30 P.M. at the Conference Room, SRA, Araneta St., Singang, Bacolod City. This shall be open to prospective bidders who shall have the option to attend either

9. Bid opening shall be on November 7, 2023; 2:30 P.M. at the given address below and will be made available via Zoom or Google Meet platform for those who choose to attend virtually. A Link will be given to those interested in bidding for the Procurement Project. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
