## INVITATION TO BID

### SUPPLY AND DELIVERY OF SEVENTEEN (17) UNITS BRAND NEW FERTILIZER APPLICATOR

1. The **Sugar Regulatory Administration** through the **2016 General Appropriations Act (GAA) Continuing Budget** intends to apply the sum of **Four Million Seven Hundred Sixty Thousand Pesos (Php4,760,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of Seventeen (17) Units Brand New Fertilizer Applicator**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Sugar Regulatory Administration (SRA)** now invites bids for **Supply and Delivery of Seventeen (17) Units Fertilizer Applicator**. Delivery of the Goods is required **within one hundred twenty (120) calendar days from receipt of the Purchase Order (PO)/Notice to Proceed (NTP)**. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.




