INVITATION TO BID FOR THE IRRIGATION PROJECT 2019-016

1. The SUGAR REGULATORY ADMINISTRATION, through the GAA SIDA 2019 intends to apply the sum of Four Million Five Hundred Thousand Pesos (₱4,500,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Irrigation Project/CN2019-018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the supply and delivery of 28 units Irrigation Pump and Engine Sets with Complete Accessories, one (1) unit Irrigation Shallow tube well set and Irrigation Conveyance System Materials. Delivery of the Goods in 30 Block Farms in Visayas is required thirty (30) days upon receipt of Purchase Order. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the SUGAR REGULATORY ADMINISTRATION and inspect the Bidding Documents at the address given below during 8:00 a.m. to 5:00 p.m.
5. A complete set of Bidding Documents may be acquired by interested Bidders from October 30, 2019 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of ₱4,500.00.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The SUGAR REGULATORY ADMINISTRATION will hold a Pre-Bid Conference on November 7, 2019, 9:30 a.m. at the SRA Conference Room, Sugar Regulatory Administration, Araneta St., Singang, Bacolod City, which shall be open to prospective bidders.


