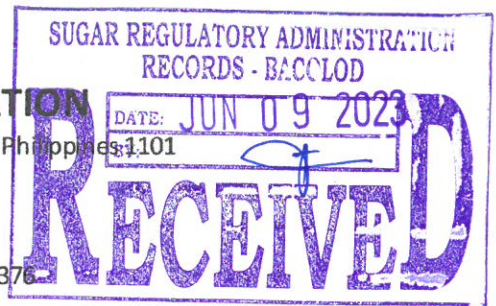

INVITATION TO BID FOR SUPPLY AND DELIVERY OF VEHICLES 2023-COB-07

1. The SUGAR REGULATORY ADMINISTRATION, through the Corporate Operating Budget 2023 intends to apply the sum of:
 - One Million Nine Hundred Thousand Pesos (₱1,900,000.00) for Item A
 - One Million Nine Hundred Thousand Pesos (₱1,900,000.00) for Item B
 - Three Million Six Hundred Thousand Pesos (₱3,600,000.00) for Item C

The above-stated being the ABCs to payments under the contract for:

Item	Contract Identification No.
A. One (1) unit Sports Utility Vehicle (SUV)	2023-COB-07-A
B. One (1) unit Pick-up Truck (4WD)	2023-COB-07-B
C. Two (2) units Pick-up Trucks (4WD)	2023-COB-07-C

Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

2. The SUGAR REGULATORY ADMINISTRATION now invites bids for the above Procurement Project. Delivery of the Goods is required by thirty (30) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on July 3, 2023; 11:00 A.M. at the given address below and will be made available via Zoom platform for those who choose to attend virtually. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The SUGAR REGULATORY ADMINISTRATION reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
